



Roe v. Wade Was Overturned! What Does That Mean for PA?

*We've been freed from the shackles of Roe,
now we have a world of new possibilities!*

Over 30,000 lives - The number of abortions still occurring annually in our state. Overturning Roe and Casey does not automatically change existing state law in Pennsylvania.

6 months - A woman is permitted to have an abortion through the first six months in pregnancy (24 weeks). There are some exceptions to allowing an abortion after the legal limit and those must be performed in a hospital.

24 hours - Pennsylvania has a 24-hour waiting period along with requirements for informed and parental consent. Additional limits such as a ban on late-term abortions and on targeting babies diagnosed with Down Syndrome, were vetoed by Gov. Wolf.

\$30 million - State law prohibits taxpayer-funded policies on the state health insurance exchange from paying for abortion. While taxpayers are currently not forced to pay for elective abortions, Planned Parenthood has received over \$30 million in taxpayer funding since 2012 (just not directly for abortion services).

18 clinics - There are 18 freestanding abortion facilities in Pennsylvania. While the Philadelphia Women's Center carries out the most abortions of any one location (over 6,000 abortions every year), Planned Parenthood operates 12 abortion facilities that profit from more than half of all abortions in Pennsylvania annually.
